A Swift Summary of Wellbeing Stuff for Funders

October's edition of FundWell is curated by Risk Pool Fund

Hello Changemakers,

Delivering development and humanitarian programs is no easy feat, particularly for organizations working in fragile, conflict-affected regions or areas facing the growing impacts of climate change. Many also contend with unpredictable financial or policy shifts that complicate their operations. In these volatile environments, obstacles that delay or derail projects are common, yet there is no standardized approach for organizations or funders to predict, mitigate, or address these challenges efficiently. Although the sector heavily relies on grant funding, securing timely support to overcome obstacles remains a persistent struggle for many.

Recent research conducted on behalf of the Risk Pool Fund sheds light on a critical issue: the disconnect between funders and implementing partners regarding the real challenges faced in the field. Local NGOs, in particular, encounter more frequent and severe obstacles compared to their international counterparts, often with fewer resources to manage them. While risk management strategies tend to focus on security or financial concerns, funders and implementers alike identify bureaucratic delays as the most common roadblock-yet current tools fail to address this.

In response to these gaps, the Risk Pool Fund (RPF) offers an innovative solution. Recognizing that even with careful planning, unexpected challenges can arise, the RPF provides financial support of up to \$50,000 for implementers to tackle unforeseen obstacles. Since its inception, the fund has helped safeguard over \$90 million in project investments, demonstrating the impact of a flexible, responsive approach to risk management. With 97% of funded projects reporting successful outcomes, the RPF is proving to be a game-changer for organizations navigating the complexities of development and humanitarian work.

- As an implementer how can I make my case for support for the unpredictable and drive my funders away from passing responsibility to mitigate risk entirely to the implementers.
